**Title: Bringing educational research into the classroom: Models, resources and  
practical proposals**

Undergraduate and Postgraduate Students of the University of Crete (1<sup>st</sup> cycle of studies) are invited to apply for blended intensive program mobility under the Erasmus+ framework.

**In total:** 6 eligible positions for students of the Department of Preschool Education of the University of Crete for the Erasmus+ Blended Intensive Program (BIP), which is organized during the spring semester of the academic year 2025–2026 by the University of Málaga, Faculty of Education, Spain (1<sup>st</sup> cycle of studies).

The BIP entitled Bringing educational research into the classroom: Models, resources and practical proposals is part of the training in Methodology, Resources and Techniques in Educational Research as a practical training complement to other formative programs offered by faculties of visiting students. Its objectives are as follows:

1. To strengthen the connection between current educational research and future teaching practice at university context through reflect and create a space for the exchange and codesign of innovative pedagogical proposals.
2. To identify, analyze and compare current models of training in educational research among students' participants, evaluating their strengths and weaknesses and identifying transferable good practices.
3. To promote digital teaching skills through the use of technological tools for research and educational practice (data analysis, multimedia resources, virtual classrooms, etc.)

The aim is to reflect, share and create a common theoretical and practical discourse about the scope and challenges of educational research as a basic subject in the future teachers' training, addressing topics close to the students' interests.

#### **Requirements/ Academic background/ Level of studies**

1. Undergraduate Students of the Department of Preschool Education (first cycle of studies)
2. Students of the Department of Preschool Education who have successfully completed the courses:
  - a) Methodology of Psychoeducational Research and
  - b) Statistics Iwhich are offered in the second year of studies
3. Additional points (not exclusion) will be awarded to students who have successfully completed the courses:
  - a) Statistics in Education II
  - b) Research Seminar and Statistical Analysis Education
4. English Language Proficiency (Certificate of at least B2 Level)
5. Curriculum Vitae
6. Motivation Letter

If a tie still remains after the evaluation of the above criteria, the Selection Committee conducts a draw.
